Sub: Notifying the additional inclusion of CFS Area of 12915.21 Sqm. (3.19 acres) in respect of Container Freight Station setup by M/s. Raja Agencies, as 'CUSTOMS AREA' under section 8(b) of the Customs Act, 1962 - Reg.

Attention of all is invited to the Public Notice No. 35/2002 dated 29.05.2002 and Facility Intimation No.10/2008 dated 19.07.2008 notifying the CONTAINER FREIGHT STATION set up by M/s Raja Agencies, situated at Harbour Express Road, Opp. Thermal Nagar Camp 1, Tuticorin - 628 006 as 'CUSTOMS AREA' under Section 8(b) of Customs Act, 1962.

Now, in exercise of the powers conferred under Section 8 (b) of the Customs Act 1962, the premises of CONTAINER FREIGHT STATION set up by M/s Raja Agencies, Tuticorin notified under Public Notice No. 35/2002 dated 29.05.2002 and Facility Intimation No.10/2008 dated 19.07.2008 is partially modified to the extent of inclusion of additional area of 12915.21 Sqm. (3.19 acres) in Survey No. 1/1 of Mullakadu Village, Tuticorin situated at the back side of the existing CFS area for the purpose of de-stuffing of Import laden containers, storage & Customs examination of Import cargo as well as for the purpose of storage, Customs examination of cargo meant for export and stuffing into containers under the supervision of Customs.

The description of the CFS Area after inclusion of additional land area of 12915.21 Sqm. (3.19 acres) taken on lease and location of the premises is as shown below;

02. CFS Premises having an area of 29702.27 Sqm. (7.51 Acres) of land by M/s. Raja Agencies, Tuticorin situated in survey No. 1/2A2A, 1/2B, 1/2C1 and 1/1 on the Harbour Express Road, Opp. Thermal Nagar Camp 1, Tuticorin - 628 006, with boundaries on four sides as noted below.

Northern Side : Railway Line
Eastern Side : Port Trust Vacant Land
Western Side : Private Vacant Land
Southern Side : National Highway Service Road
